Sulphur rules were imposed as per 1 January 2015 to reduce sulphur emission by 2016 in the Sulphur Emission Area (SECA) of the Baltic Sea, the North Sea and the English Channel.

From January 1, 2020, the Irish Sea was included to the Sulphur Emission Area (SECA) to reduce Sulphur emission even more. The SECA fee is calculated after payable weight.
